

**ORDINANCE NO. 328**

**AN ORDINANCE OF THE CITY OF PORT ST. JOE, FLORIDA AMENDING ORDINANCE NO. 295 ADOPTED OCTOBER 15, 2002, PROVIDING FOR A NEW SCHEDULE OF CAPITAL IMPROVEMETNS, DELETING PREVIOUSLY ADOPTED SCHEDULE OF CAPITAL IMPROVEMENTS; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH, PROVIDING FOR SEVERABILITY AND PROVIDING FOR AN EFFECTIVE DATE.**

**NOW, THEREFORE, BE IT ENACTED BY THE PEOPLE OF THE CITY OF PORT ST. JOE, FLORIDA AS FOLLOWS:**

Section 1. Table No. 4 Port St. Joe Capital Improvements Element as adopted in Ordinance No. 295, which reads as follows:

**REPEAL:** All ordinances or parts of ordinances in conflict herewith are hereby repealed.


**EFFECTIVE DATE:** This ordinance shall become effective as provided by law.
