### **EQUIPMENT OPERATOR I**

---

**DEPARTMENT:** PUBLIC WORKS – Solid Waste

**GENERAL DESCRIPTION:**

Skilled work in the operation of a Peterson Lightning Loader, duties also include the performance of manual laboring tasks. Works under direct supervision of the Operations Supervisor and Public Works Director.

**ESSENTIAL JOB FUNCTIONS:**

1. Operates one or more of the following list of equipment and/or machines: Peterson Lightning Loader; front-end loader; backhoe; mini-excavator.
2. Operates lighter equipment such as a dump truck.
3. Performs routine first echelon maintenance to the equipment.
4. Performs manual laboring tasks.

(These essential job functions are not to be construed as a complete statement of all duties performed. Employees will be required to perform other duties as required.)

**MINIMUM QUALIFICATIONS:**

**KNOWLEDGE, ABILITIES AND SKILLS:**

Knowledge of the effective operation of medium and heavy equipment. Knowledge of traffic and highway safety rules and regulations, and of effective precautionary measures necessary to avoid accidents. Knowledge of the hazards involved in the use of heavy equipment and of the safety precautions to be taken. Ability to understand and carry out general instructions relating to construction and maintenance operations. Ability to understand and follow oral and written instructions.

**EDUCATION AND EXPERIENCE:**

High school graduation or possession of an acceptable equivalency diploma.
