ORDINANCE NO. 20

AN ORDINANCE AMENDING ORDINANCE NO. 16 ADOPTED BY THE CITY COMMISSION OF THE CITY OF PORT ST. JOE, ON THE 29th DAY OF JANUARY, 1965, ENTITLED AS FOLLOWS: "AN ORDINANCE REGULATING THE CONSTRUCTION, ALTERATION, REPAIR AND MOVING OF BUILDINGS WITHIN THE CITY OF PORT ST. JOE, FLORIDA; PROVIDING FOR FERMITS AND FEES THEREOF; PROVIDING FOR PENALTIES FOR VIOLATION THEREOF; AND PROVIDING FOR THE REPEAL OF ALL ORDINANCES IN CONFLICT HEREWITH.", BY ADDING NUMERICAL TITLE XVIII, PROVIDING THAT THE PROVISIONS OF THE SOUTHERN STANDARD BUILDING CODE SHALL BE INCOPPORATED IN SAID ORDINANCE BY REFERENCE; AND PROVIDING AN EFFECTIVE DATE.

BE IT ENACTED BY THE PEOPLE OF THE CITY OF PORT ST. JUE:

SECTION 1. That Ordinance No. 16 be, and the same is hereby, amended by adding Title XVII immediately following Section 5 of Title XVII to read as follows:

XVII.

SECTION 1. The provisions of the 1960-61 edition of the Southern Standard Building Code and amendments thereto as the same are adopted, insofar as said Code provides for standards of design and construction are hereby incorporated in Ordinance No. 16 by reference, and in the interpertation of Title XIII of Ordinance No. 16, the Provisions of Southern Standard Building Code or the provisions of Title XIII of Ordinance No. 16 shall be utilized by the building inspector for standards of design and construction in the City of Port St. Joe, and in the event of conflicts between the standards contained in Title XIII of Ordinance No. 16 and those of Southern Standard Euilding Code, the lesser standards of design and construction shall be required.

SECTION 2. That in the event Title XIII of Ordinance No. 16 is silent on any standards of design and construction which are contained in Southern Standard Building Code, the provisions of Southern Standard Building Code and amendments thereto shall be required in the same manner as if they were written verbatim in Title XIII of Ordinance No. 16.

SECTION 3. This Ordinance shall take effect immediately.
