ORDINANCE NO. 256

AN ORDINANCE AMENDING SECTION 62, TAXATION, OF THE CODE OF ORDINANCES, CITY OF PORT ST. JOE, FLORIDA, BY ESTABLISHING A NEW ARTICLE ENTITLED ARTICLE I. ADDITIONAL HOMESTEAD EXEMPTION FOR SENIOR CITIZENS, SECTIONS 62, 1-6 INCLUSIVE; BY PROVIDING AN ADDITION \$25,000.00 HOMESTEAD EXEMPTION TO QUALIFIED SENIOR CITIZENS; PROVIDING TERMS AND CONDITIONS OF ENTITLEMENT; PROVIDING FOR SEVERABILITY AND REPEALER; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, on November 3, 1998, an amendment to the Florida constitution was approved providing an additional homestead exemption to certain qualifying senior citizens; and

WHEREAS, the City Commission desires to implement the additional homestead exemption for qualifying senior citizens in accordance with the provisions of Section 196.075 of the Florida Statutes, as authorized by the 1999 session of the Florida Legislature through its enactment of House Bill 291; and

WHEREAS, the City Commission desires to provide this additional tax relief to its senior citizens and has determined that the adoption of this ordinance serves to protect the health, safety and welfare of the general public; now therefore,

BE IT ORDAINED BY THE PEOPLE OF THE CITY OF PORT ST. JOE, FLORIDA:

SECTION ONE. Section 62, Taxation, Code of Ordinances of the City of Port St.

Joe, Florida, is hereby amended by adding a new article and sections thereto, to be numbered and titled as Article I, Additional Homestead Exemption for Senior Citizens, Sections 62, 1-6, inclusive, that shall read as follows:

The additional homestead exemption, if granted, shall be (q) applicable to all ad valorem tax millage rates levied by the City; and, if applicable, shall be subject to the provisions of Sections 196.131 and 196.161, Florida Statutes. If title to the property is held jointly with right of survivorship, the person residing on the property and otherwise qualifying for the additional homestead exemption may receive the entire amount of the additional homestead exemption provided herein.

(c) The additional homestead exemption provided herein shall be available to qualified persons beginning with the year 2000 tax roll as soon as the appropriate forms are available from the Florida Department of Revenue.

Sec. 62-4. Annual adjustment of income.

Beginning January 1, 2001, and continuing every January 1st thereafter, the \$20,000.00 income limitation shall be automatically adjusted by the percentage of change in the average cost-of-living index in the period of January 1st through December 31st of the prior year as compared to the same period for the year prior to that year. As used herein, the term "index" shall be the average of the monthly consumer-price index figures for the stated twelve month period, for the United State as a whole, issued by the United States Department of Labor.

Section 62-5. Requirements for claiming additional homestead exemption.

Every person claiming the additional homestead exemption pursuant to this article must file an application with the Gulf County Property Appraiser no later than March 1st of each year for which such exemption is claimed. The application shall be on a form prescribed by the Florida Department of Revenue and shall include a sworn statement of household income for all members of the household. On or before June 1st of each year, each applicant must file supporting documentation with the Property Appraiser, including copies of all federal income tax returns, wage and earning statements (W-2 forms), and such other documentation as may be required by the Property Appraiser, including documentation necessary to verify the income received by all members of the household for the prior year. The applicant's statement shall attest to the accuracy of all documentation provided, and the Property Appraiser shall not grant the exemption without the required documentation.
