

ORDINANCE NO. 400

AN ORDINANCE OF THE CITY OF PORT ST. JOE, FLORIDA, AMENDING ORDINANCE #388 (WASTEWATER) BY AMENDING SECTION 1 DEFINITION, AMENDING SECTION 2 BASE RATE, PROVIDE FOR REPEAL OF ALL ORDINANCES IN CONFLICT HEREWITH AND PROVIDING FOR AN EFFECTIVE DATE.

BE IT ENACTED BY THE PEOPLE OF THE CITY OF PORT ST. JOE, FLORIDA as follows:

1. Ordinance #388 Section 1b and c and Section 2b and c currently provides as follows:

(1). b. Commercial 1 is defined as any business or commercial establishment whose water usage does not exceed 1.25 ERC which equals 375 gallons per day average .

c. Commercial II is defined as any business or commercial establishment whose water usage exceeds 1.25 ERC which is equals 376 gallons per day average.

2. Ordinance #388, Section 1b and c and Section 2b and c, is amended as follows:

(1) b. Commercial 1 is defined as any business or commercial establishment whose water usage does not exceed 1.50 ERC which equals 450 gallons per day and up to 13,500.00 gallons for 30 days

c. Commercial II is defined as any business or commercial establishment whose water usage exceeds 1.50 ERC which is greater than 450 gallons per day average.

3 Repeal. All ordinances or parts of ordinances in conflict herewith

are hereby repealed.

4. Severability. If any section, subsection, sentence, clause or provision of this ordinance is held invalid, the remainder shall not be affected by such invalidity.

5. Effective Date. This ordinance shall become effective on passage.
