

ORDINANCE NO. 73

AN ORDINANCE AMENDING ORDINANCE NO. 72 ADOPTED BY THE CITY COMMISSION OF THE CITY OF PORT ST. JOE, ON THE 15th DAY OF OCTOBER, 1974, ENTITLED AS FOLLOWS: "AN ORDINANCE RELATING TO THE LEVY OF TAXES IN THE CITY OF PORT ST. JOE, FLORIDA, FOR THE TAX YEAR 1974, LEVYING AN AD VALOREM TAX OF 5.5 MILLS ON ALL REAL AND PERSONAL PROPERTY WITHIN SAID CITY, WHICH IS NOT EXEMPT UNDER LAW, FOR THE PURPOSE OF PROVIDING FUNDS FOR THE ORDINARY AND REGULAR REQUIREMENTS OF THE CITY OF PORT ST. JOE FOR FISCAL YEAR 1974/75; PROVIDING AN EFFECTIVE DATE AND DECLARING THE ADOPTION OF SAID ORDINANCE TO BE AN EMERGENCY." AMENDING ALL ORDINANCES IN CONFLICT HERewith AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City Commission is of the opinion that it is necessary for the immediate protection and preservation of the peace, safety, health and property of the City and its inhabitants, and to provide for the usual daily operation of the City and its departments, that this Ordinance be enacted and take effect immediately, therefore

BE IT ENACTED BY THE PEOPLE OF THE CITY OF PORT ST. JOE:

Section I. That there be, and there is hereby, levied and assessed upon all property, both Real and Personal, within the Corporate Limits of the City of Port St. Joe, not exempt from taxation by the Constitution and Laws of the State of Florida, the following Ad Valorem Taxes for the Year 1974.

- A. A tax of 5.28 mills upon the dollar of assessed valuation for the purpose of providing funds for the ordinary and regular purposes of the City of Port St. Joe, Florida, for the Fiscal Year 1974/75; said valuation to be based upon the Assessment Roll of said City as previously approved and adopted.

Section II. Any and all ordinances in conflict herewith are hereby amended to conform to this ordinance.

Section III. This Ordinance shall take effect immediately upon adoption.

INTRODUCED at the special meeting of the City Commission on the 20th day of December, A.D. 1974, and ADOPTED by the City Commission on the 20th day of December, A.D. 1974, as an emergency ordinance.
