

ORDINANCE NO. 111

AN ORDINANCE AMENDING SECTION IA OF ORDINANCE NO. 108 ENTITLED: "AN ORDINANCE RELATING TO THE LEVY OF TAXES IN THE CITY OF PORT ST. JOE, FLORIDA, FOR THE TAX YEAR 1979, LEVING AN AD VALOREM TAX OF 5.3 MILLS ON ALL REAL AND PERSONAL PROPERTY WITHIN SAID CITY, WHICH IS NOT EXEMPT UNDER LAW, FOR THE PURPOSE OF PROVIDING FUNDS FOR THE ORDINARY AND REGULAR REQUIREMENTS OF THE CITY OF PORT ST. JOE FOR FISCAL YEAR 1979/80; PROVIDING AN EFFECTIVE DATE AND DECLARING THE ADOPTION OF SAID ORDINANCE TO BE AN EMERGENCY." AND PROVIDING FOR AN EFFECTIVE DATE.

BE IT ENACTED BY THE CITY OF PORT ST. JOE:

Section I. That Section IA of Ordinance No. 108 be, and it is hereby, amended so as to read as follows:

IA. A tax of 4.77 mills upon the dollar of assessed valuation for the purposes of providing funds for the ordinary and regular purposes of the City of Port St. Joe, Florida, for the Fiscal Year 1979/80; said valuation to be based upon the Assessment Roll of said City as previously approved and adopted.

Section II. This Ordinance shall take effect immediately upon adoption.

ORDINANCE NO. 112

AN ORDINANCE AMENDING SECTION IA OF ORDINANCE NO. 111 ENTITLED: "AN ORDINANCE RELATING TO THE LEVY OF TAXES IN THE CITY OF PORT ST. JOE, FLORIDA, FOR THE TAX YEAR 1979, LEVYING AN AD VALOREM TAX OF 5.3 MILLS ON ALL REAL AND PERSONAL PROPERTY WITHIN SAID CITY, WHICH IS NOT EXEMPT UNDER LAW, FOR THE PURPOSE OF PROVIDING FUNDS FOR THE ORDINARY AND REGULAR REQUIREMENTS OF THE CITY OF PORT ST. JOE FOR FISCAL YEAR 1979/80; PROVIDING AN EFFECTIVE DATE AND DECLARING THE ADOPTION OF SAID ORDINANCE TO BE AN EMERGENCY." AND PROVIDING FOR AN EFFECTIVE DATE.

BE IT ENACTED BY THE CITY OF PORT ST. JOE:

Section I. That Section IA of Ordinance No. 111 be, and it is hereby, amended so as to read as follows:

IA. A tax of 4.87 mills upon the dollar of assessed valuation for the purposes of providing funds for the ordinary and regular purposes of the City of Port St. Joe, Florida, for the Fiscal Year 1979/80; said valuation to be based upon the Assessment Roll of said City as previously approved and adopted.

Section II. This Ordinance shall take effect immediately upon adoption.
