# MINUTES OF THE REGULAR MEETING OF THE BOARD OF CITY COMMISSIONERS FOR THE CITY OF PORT ST. JOE, FLORIDA, HELD AT 2775 GARRISON AVENUE, April 18, 2017, AT 6:00 P.M.

The following were present: Mayor Patterson, Commissioners Lowry, and Thursbay. City Manager Jim Anderson, City Clerk Charlotte Pierce, and Attorney Clinton McCahill were also present. Commissioners Ashbrook and Buzzett joined the meeting after it was called to order.

#### **CONSENT AGENDA**

#### Minutes

A Motion was made by Commissioner Thursbay, second by Commissioner Lowry, to approve the Minutes of the Regular Meeting on April 4, 2017, and the Special Commission Meeting of April 11, 2017. All in favor; Motion carried 3-0.

Mayor Patterson moved the Public Works Report up in the meeting so Mr. Grantland could attend his son's ballgame.

Commissioner Buzzett joined the meeting at 6:02 and Commissioner Ashbrook joined the meeting at 6:07 P.M.

#### Public Works - John Grantland

*Utility Permit* – After discussion, it was the consensus of the Commission that there needs to be either an Ordinance or Resolution that sets a Permit Fee, provides for charges incurred when a City employee is needed and allows for a penalty fee when a contractor fails to get a permit. Staff is to contact other cities to see what they have for this type permit. A draft Ordinance / Resolution is to be prepared for the May 2<sup>nd</sup> meeting.

#### PORT ST. JOE REDEVELOPMENT AGENCY (PSJRA)

Lighthouse Keepers' Quarters Renovation; RFP 2017-01, Request to Award Bid:

Commissioner Buzzett updated the Commission on the bidding process and noted that the following were the low bidders for the project.

Philco (AC Only) \$13,925; Current Solutions (Electric only) \$12,800; Combs Construction (Exterior of Building) \$37,400. As Executive Director of the PSJRA, Bill Kennedy will serve as the General Contractor for the Project.

A Motion was made by Commissioner Thursbay, second by Commissioner Buzzett, to approve the bids pending state approval. All in favor; Motion carried 5-0.

#### **PDRB Recommendation**

Modular Home Building Permit – Shannon Winfield, 170 Avenue E:

Consensus of the Commission was that this should be handled at City Staff level by the Building Department and did not need to come before the Commission. The recommendation of the Planning Development and Review Board was to approve the permit. It was noted that all future permits will be handled by the Building Department and requests will not be sent to the Commission.

#### CITY ATTORNEY -

Resolution 2017-04, Proposed Home Rule Legislative Bills – Attorney McCahill read Resolution 2017-04 by Title only.

A Motion was made by Commissioner Buzzett, second by Commissioner Ashbrook, to approve Resolution 2017-04. All in favor; Motion carried 5-0.

Resolution 2017-05, Fishing Regulations - Attorney McCahill read Resolution 2017-05 by Title only.

A Motion was made by Commissioner Thursbay, second by Commissioner Lowry, to approve Resolution 2017-05. All in favor; Motion carried 5-0.

#### CITY MANAGER'S REPORT - Jim Anderson

#### **Old Business**

Commerce Park Lot Utilities Update – Staff continues to work on the relocation of the utilities. The agreement for the property closes Friday and an extension of 10 days may be needed.

CDBG Grant Update – Bruce Ballister: Mr. Ballister noted that the grant is on track, and there is a new grant reviewer that has held all grants to higher review standards. He anticipates receiving the Notification for Release of Funds soon and once that is received, advertising may begin for construction.

#### **New Business**

Road Abandonment Request - Kay Haddock: This item was Tabled.

Escrow Deposit – Commerce Park Lot: A Motion was made by Commissioner Buzzett, second by Commissioner Ashbrook, to refund the Escrow Deposit in the amount of \$500 to Franky Williams who originally wanted to purchase the property but did not complete the transaction. All in favor; Motion carried 5-0.

St. Joe Co. Payment Request – A request has been received from the St. Joe Company for their portion of 50% of all new sewer connections made from Windmark to Overstreet. This was a previous agreement and will expire in May of 2018. Funds collected to date total \$123,552.80 less \$29,200 credit in unpaid Tap Fees. A check in the amount of \$94,352.80 will be remitted to the St. Joe Company. Commissioner Buzzett commended Staff for their work done on this.

FRDAP Committee Membership – A Motion was made by Commissioner Ashbrook, second by Commissioner Thursbay, to add Jessie Pippin and Kari Williams to the FRDAP Committee. These names were submitted by Sara Hinds of the Gulf County Health Department. All in favor; Motion carried 5-0.

**Surface Water Plant – Larry McClamma** shared that Liquid Engineering had cleaned out and inspected the 2,000,000 gallon ground storage tank at the plant. Their report was that the tank is in overall good condition.

Financial Analyst – Mike Lacour advised that the playground equipment for Dooder Parker Park has been ordered and should be here in 6-8 weeks.

**Wastewater Plant – Kevin Pettis** noted that Biological Dredging along with Environmental Associates of LA added product to the lagoon. They will sample tomorrow and several more times over the next few months to check the PH and DO of the lagoon. Indications are that previous treatments to the lagoon have removed more sludge than originally thought. The plant is running well and they are continuing to spray.

#### City Engineer - Clay Smallwood, III

Project Updates -

Frank Pate Park Boat Ramp Improvements – Sheet pilling has been delivered, it will be installed this Thursday, and the contractor is gearing up this week for the project. Complaints have been received about the lack of work going on but the contractor has assured Mr. Smallwood the project will be finished on time.

Long Avenue - Staff has the plans for the project.

Jones Homestead Sewer - Dewberry / Preble-Rish continues to work on the Task Order.

#### Code Enforcement -

General Update - Mr. Burkett's report was reviewed, no action was required.

**Police Department – Chief Matt Herring** shared that the Cadet Unit received a funding grant from the Tapper Foundation today. He expressed his appreciation to the foundation for the funding.

The Port St. Joe Police Department Public Safety Day will be held on June 24, 2017, from 10 A.M. to 2 P.M. in the parking lot around First Baptist Church. Participation commitments have been received from 15 police departments, 4 sheriff's departments, Bay County Bomb Squad, EMS, Life flight helicopter, Coast Guard for a boat, Gulf County Health Department, and Emergency Operations Center. Hospitality items will be provided by First Baptist Church and Centennial Bank.

City Clerk - Charlotte Pierce did not have anything to share.

#### Citizens to be Heard -

Chester Davis, NPSJ PAC, invited the Commissioners to their 11 A.M. meeting on April 22, 2017, at Philadelphia Primitive Baptist Church, 261 Avenue D. Representatives from Gateway Apartments and the PACES Foundation will be present to discuss applications for residency at the apartments.

Pastor Davis also asked if a blight and amnesty pickup could be scheduled. Mr. Anderson shared that in the past, Amnesty Day covered only paint, oils, etc., and they had to be delivered to a predetermined location. Roadside pickups, other than yard debris, require a special pickup because our current tipping fees from Waste Pro are \$51.50 a ton.

Mr. Davis inquired as to whether the county was going to be able to burn debris from the houses to be demolished.

Letha Mathews asked what qualifies as "blighted." Mr. Anderson responded that a request will need to be made to the City Code Enforcement Officer who maintains a list of the requests.

#### **Discussion Items by Commissioners**

Commissioner Buzzett thanked the Tapper Foundation for their generosity and noted \$70,000 was given to local organizations today. He encouraged citizens to thank Trish Tapper Warriner and David for their continued philanthropy to our area.

Commissioner Lowry did not have anything to discuss.

Commissioner Ashbrook reminded everyone to be sure and vote in the upcoming election.

Commissioner Thursbay noted that he had visited with some of the "finest people on earth" while campaigning, was blessed to live here, reminded everyone of the forthcoming election and encouraged the citizens to vote.

Mayor Patterson asked if customers were 2 months behind w Mr. Anderson responded that the policy can be "tightened up" direction from the Commission on their wishes.

The Permitee agrees that its assumption of risks and obligations to indemnify the City related to Permittee's work or placement of any improvements shall survive the expiration date of this Permit. The Permittee agrees to pay any and all costs, fees and expenses that the City in any way incurs relative to enforcing the terms and conditions of this Permit, including but not limited to, Attorneys' Fees and Legal Costs at trial, on appeal or at any administrative proceeding. The Permittee understands and acknowledges that any and all payments to obtain this permit only cover direct and indirect costs which the Permittee's use of public right-of-way have or will generate, and further that such payments do not encompass the fair value of Permittee's use or
- It is expressly agreed by the Permittee that this Permit is for is a License for Permissive Use only and that the placing of improvements. such as, but not limited to, utilities, facilities, roadways, structures or landscaping upon public property pursuant to this Permit shall not operate to create or vest any property right whatsoever in said Permittee, current owner/operator or adjacent property owner. The scope of this license shall not be expanded physically, functionally or as to the breadth of services permitted through it without the prior consent of the City. A copy of this permit shall be on site during construction.
- The Permittee agrees that the construction and/or maintenance of improvements shall not interfere with the property and rights of a prior occupant including, but not limited to, the City. The Permittee shall pay any and all costs and expenses in any way relating to
- In the event of rerouting, widening, repair, construction or reconstruction of public roadways, utilities, facilities or structures, the Permittee shall, within minety(90) days of receiving written notice from the City, remove or relocate its facilities within the Public rights-of-way, at no cost to City, to clear the area for the City's work.
- The Permittee and the holder of this Permit shall take all safety measures, including, but not limited to, the placing and displaying of warning/channelizing/regulatory signs, signals, lights, barricades, cones, drums, beacons, devices, pavement markings and flaggers as required by the most recent FDOT Roadway and Traffic Design Standards and shall also prevent any obstructions or conditions which are or may become dangerous to the traveling public as conclusively determined by the City of Port St. Joe. The Permittee shall be responsible for any and all costs related to loss of life, personal injury and/or property damage relating to the impedance obstruction of either pedestrian or vehicular traffic.
- If an emergency or any other situation arises which a reasonably prudent person would believe to be an emergency situation, the Permittee and the holder of this permit shall immediately take all actions necessary to ensure the safety of the traveling public and construction persons including contacting emergency services such as police, medical or fire. Permittee will contact and advise the City of Port St. Joe of the situation and take any and all remedial actions in addition to those required by the Public Works Department,
- Prior to any construction, a 24-7 emergency phone number shall be provided to the City and/or placed at the work site and shall be visible from a public access point, Permittee agrees to obtain all required approvals, agreements and/or permits relative to the type and location of the proposed work from all Federal, State, County, City, real property owner and any other Regulatory Agency or Department. The Permittee, Owner, Agent or Contractor must obtain a Federal NPDES Permit if the proposed construction disturbs
- Any work that commences without all required State, Regional or Local Permits available on the job site or without establishing: 1) shall be immediately suspended until all requirements have been met and penalty fees, if any, are paid. The penalty fee for work that commences without a Permit shall be no less than the Permit fee for each occurrence. Additionally, failure to obtain a Permit may result in a case being filed with the Code Enforcement Department of The City of Port St. Joe or other appropriate actions in accordance with State Law and City Ordinances. In the event this Permit is subject to or issued in conjunction with any other Permit, whether State, Regional or Local, this Permit shall automatically be suspended indefinitely if such other Permit is terminated or
- Permittee declares that prior to any construction or excavation, notice as required and as necessary in accordance with sound operating and engineering practices, will be issued to the owners of real property, owners/operators of all existing utilities, facilities or

#### **ORDINANCE NO.: 531**

AN ORDINANCE REPEALING AND REPLACING ORDINANCE 311 AND 488 OF THE CODE OF THE CITY OF PORT ST. JOE PERTAINING TO APPLICATION; DEPOSIT, CONNECTION AND ACCOUNT TRANSFER FEES; PROVIDING FOR THE REPEAL OF ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH AND PROVIDING FOR AN EFFECTIVE DATE.

#### BE IT ENACTED BY THE PEOPLE OF THE CITY OF PORT ST. JOE, FLORIDA:

- (a) Before service of water and/or sewerage shall be installed or furnished by the city; the person desiring such service shall make written application to the city auditor and clerk for the service desired, and shall deposit with the city treasurer the sum of \$150.00 plus first month's trash service, provided that in case of larger consumers, where the monthly consumption and the established rate will likely exceed the sum of \$150.00, the amount of the deposit to be required shall be such sum as in the judgment of the city auditor and clerk will be adequate to protect the city from loss.
- (b) Upon receipt of the deposit provided for in this section, the city treasurer shall issue receipt to the party paying the sum. All deposits made under the provisions of this section will be refunded on demand whenever the service is discontinued and all accrued bills for service have been paid. Any person changing residence or business location may withdraw any deposit made for service at such place, but before service is again furnished such person at a new location, written request therefore and deposit must be made for service at such new location as provided in this section.
- (c) There shall be a charge of \$35.00 for each new service connection and for transferring the utility account from the name of one person to the name of another, which shall be paid before service connection is made or account changed, provided that there shall be no service connection charge or change account charge when a new service connection is made for which a tapping fee is paid.
- (d) Temporary Service: There shall be a \$50.00 deposit for temporary service(14 days) and the \$35.00 new service connection charge referred to in (c) above shall also apply.

**REPEAL**: All ordinances or parts of ordinances in conflict herewith are hereby repealed.

**EFFECTIVE DATE**: This ordinance shall become effective upon adoption.
