MINUTES OF THE REGULAR MEETING OF THE BOARD OF CITY COMMISSIONERS FOR THE CITY OF PORT ST. JOE, FLORIDA, HELD AT 2775 GARRISON AVENUE, December 5, 2017, AT 6:00 P.M.

The following were present: Mayor Patterson, Commissioners Ashbrook, Buzzett, Lowry, and Thursbay. City Manager Jim Anderson, City Clerk Charlotte Pierce, and Attorney Clinton McCahill were also present.

CONSENT AGENDA

Minutes

A Motion was made by Commissioner Ashbrook, second by Commissioner Buzzett, to approve the Minutes of the Regular Commission Meeting of November 7, 2017. All in favor; Motion carried 5-0.

PORT ST. JOE REDEVELOPMENT AGENCY (PSJRA)

MLK and Avenue C Sidewalks – PSJRA Chairman, Rex Buzzett, requested that this be Tabled until the next meeting.

CITY ATTORNEY -

Attorney McCahill requested that Ordinance 544 be moved ahead of the Attorney General Opinion issue.

Ordinance 544 Parcel #04939-000R, 208 7th Street – Residential in a C-1 District, Public Hearing, 2nd Reading and Consideration of Adoption:

Mayor Patterson asked if anyone from the Public wished to speak on this issue. No one from the public responded.

A Motion was made by Commissioner Lowry, second by Commissioner Ashbrook, to have the Second Reading of Ordinance 544. All in favor; Motion carried 5-0.

A Motion was made by Commissioner Ashbrook, second by Commissioner Lowry, to adopt Ordinance 544. All in favor; Motion carried 5-0.

Attorney General Opinion – A Motion was made by Commissioner Lowry, second by Commissioner Ashbrook, to request an opinion from the Attorney General concerning how the charter reads in Commissioner Thursbay's situation. All in Favor Motion carried 5-0.

Commissioner Buzzett asked Attorney McCahill's interpretation of the Charter.

Attorney McCahill responded that it is fairly straightforward for what it says, that if a commissioner is convicted of a crime, he shall forfeit his office. He has found nothing in his research that would say that we would go against that at this particular time, nothing that says that the Charter is wrong or shouldn't be interpreted as far as what it says.

CITY MANAGER'S REPORT - Jim Anderson

Old Business

19th Street Bridge - Commissioner Lowry did not have any updates for this.

Centennial Building Train – Commissioner Buzzett noted this is a hard decision. The train repairs need to either be taken up by a group as a restoration project or fenced to prevent access to it.

Core Park Rentals – Workshop Scheduled for 12/12/17 at Noon at Core Park: Mr. Anderson reminded the Commissioners of the Workshop.

Replacement of Water Meters – A Motion was made by Commissioner Buzzett, second by Commissioner Ashbrook, to purchase Water Meters from Consolidated Pipe and Supply Company, Inc., in the amount of \$234,825.20 and installed by Central Plant Technology, Inc., at a price of \$44,700. All in favor; Motion carried 5-0.

New Business

Bruce Ballister – 1st CDBGF Public Hearing:

Mr. Ballister informed the Commissioners that this was an advertised First Public Hearing to take public comment on the possibility of a new grant application to DEO's CDBG for the next cycle. That cycle may open in the April to June time period next year, pending adoption of another rule change.

The Citizens Advisory Task Force had met earlier in the day and concluded that the North Port St. Joe neighborhood was the most likely area to be funded due to the demographics and the concentration of low income families there. The need to continue replacement of the high maintenance sewers was suggested.

The Commissioners agreed that North Port St. Joe was probably the only neighborhood that could be successful when scored on family income. Mr. Ballister reminded the Commission that this meeting was an opportunity for the public to come forward with any possible other projects that might include drainage, paving, utilities or community facilities.

Mayor Paterson asked the members of the public in attendance if there were any other proposals that might be put forward for discussion. There were no responses from the public.

A Motion was made by Commissioner Ashbrook, second by Commissioner Lowry, to pursue a grant to improve infrastructure in North Port St. Joe, probably sewers. All in favor; Motion carried 5-0.

FRQ 2017-02, Professional Planning Services – A Motion was made by Commissioner Ashbrook, second by Commissioner Buzzett, to accept the proposal of Stantec for RFQ 2017-02 Professional Planning Services. This will be done by Task Order and renewable on an annual basis. All in favor; Motion carried 5-0.

NWFWMD Funding Request 2018 / 2019 – Mr. Anderson anticipates a spring application time for this. Commissioner Buzzett suggested that the down town area be considered. Staff will begin work on a plan.

Port City Trail Grant – Update; Solar Lighting - Commissioner Ashbrook had requested that a presentation be made to the Commission but the presenter had a family emergency and was unable to attend.

The Commissioners discussed the holiday schedule and consensus was to have the scheduled Regular Meeting on December 19, 2017, and cancel the January 2, 2018, meeting.

Public Works - John Grantland

Holiday Lighting – Mr. Grantland requested that the Commissioners provide him with their list of where lighting is needed so that he can produce a master list for consideration.

Odor Scrubber – A Motion was made by Commissioner Thursbay, second by Commissioner Ashbrook, to purchase an Odor Scrubber for the St. Joe Beach Lift Station near Atlantic and Americus Avenues from Pump and Process in the amount of \$24,830. This Motion also required that \$2,000 per year be escrowed for filter replacements. All in favor; Motion carried 5-0.

Charles Gathers cautioned that here are other areas that are bothered by odors from lift stations and the cost is rather high for one station.

Joe Mazerick, a resident of St. Joe Beach, thanked the Commission for their action and invited them to sit in his gazebo to see how bad the smell has been.

Stan Peters asked if the MLK and Avenue C Sidewalks had been discussed and was told that the issue was Tabled earlier in the meeting.

Water Line Replacement Project – Update: The CDBG Water Line Replacement will begin tomorrow at Avenue A and Highway 98.

Surface Water Plant - Larry McClamma

Update – Mr. McClamma shared that the plant passed the 4th Quarter and Yearly Disinfectant by Products test. He also noted that Travis Burge has passed the Class A Operator Test.

Commissioner Buzzett requested Mr. McClamma talk with Complete Industrial Maintenance while they are here to see what a third coat of paint for Clarifiers 3 and 4 would cost.

Mr. McClamma noted that approximately one-half of the lid for the St. Joe Beach tank has been demoed. He anticipates that it will be a week or so before the new lid is put on.

Wastewater Plant - Kevin Pettis

Update – Mr. Pettis shared there had been no spraying in November but that had resumed in December. He also noted interviews had been conducted today with three people and he was confident a good employee was in the group.

Finance Director - Mike Lacour

Update – November Financials will be in the Commissioner's City Hall Mail Boxes on Thursday. The City is waiting on the first AD Tax money from the County.

City Engineer - Clay Smallwood, III

Project Updates -

Frank Pate Park Boat Ramp Improvements – A Walk Around has been scheduled for 9:00 A.M. tomorrow at the boat ramp.

Long Avenue Water / Sewer / Road Paving - The Budget Request has been submitted for the project.

Jones Homestead Sewer – Some responses have been received from the letter provided by the City. More signups are needed.

Mr. Smallwood noted that the CDBG Project is going well, there is pipe in the ground, and could possibly be completed by the end of December

Code Enforcement

General Update – Mayor Patterson noted Mr. Burkett is working several Saturdays a month and that his reports are being received by the Commissioners.

Police Department - Chief Matt Herring did not have anything to update the Commission on.

City Clerk - Charlotte Pierce

Christmas Parade – Clerk Pierce noted that line up should be completed by 5 P.M. as the judges will begin their review then. The Christmas Parade will begin at 6 P.M. and participants appear to be equal to or even greater than last year.

Citizens to be Heard -

Letha Mathews noted there is a speeding problem on Broad Street and asked for help in eliminating the problem. Chief Herring noted they are monitoring the area and will continue to do so.

Stan Peters shared he is trying to open a restaurant and there are issues with the sidewalk. After a lengthy discussion between Mr. Peters, Mayor Patterson, Commissioner Buzzett, and Mr. Grantland, it was determined that Mr. Peters and Mr. Grantland would meet on site to look at the situation as the area includes sidewalks and fire protection systems. Originally, the PSJRA was to provide funding and the City would provide the labor but the PSJRA Board directed the funds be paid to the NPSJ PAC for consulting fees.

Mr. Grantland is to project cost for the project and see if possibly, a private contractor would do the work for what the labor from the City would cost.

Steve Womack discussed his concerns about the footbridge on 19th Street. He feels the bridge should be for pedestrian traffic only; there are sight safety issues, a golf cart crossing is too expensive, and the money required for a golf cart crossing could be better used elsewhere.

Mr. Womack addressed the issue involving Commissioner Thursbay and suggest that he should resign his position on the Commission.

Mark Manley asked for help with the Speed Limit on Garrison Avenue near his home.

Discussion Items by Commissioners

Neither Commissioners Buzzett, Lowry, nor Ashbrook had anything else to discuss.

Commissioner Thursbay read the following statement.

Guys, I am sorry, I am sorry to you Mr. Mayor, I am sorry to my fellow commissioners for the embarrassment. the trouble and waste of time I have brought to this Commission. I am sorry to all present, not present today for my poor judgement and my improper conduct which occurred several weeks ago after leaving this very place. Most of all I am sorry for the humiliation and the pain that I have caused my wonderful wife of 25 years, my parents, and my children, they especially did not deserve this and I want to publically ask for forgiveness to accept my apology. Throughout my life, I have battled with demons from time to time, most of this caused by poor decisions I have made but some things totally beyond my control. Several weeks ago, during a personal low point in my life, I consumed alcohol, that combined with my cancer medication led to my misconduct and the subsequent arrest of myself. I should have known better and I take full responsibility for my actions. To my fellow Commissioners and my family who have been so supportive. I ask for your forgiveness for this senseless act I committed. To my many friends, voters and supporters, who have stuck by me and offered their continued support thank you for this even though I may not deserve it. To those of you who have not supported me and have not voted for me. I am sure I have reinforced the negative opinion you may have had towards me. I would especially ask for your forgiveness and understanding. You may rest assured that I will spend the rest of my life, public and private, to change your opinion of me. In the past on many occasions, I have been judgmental of other people especially those who have disagreed with me. I am respectably asking you not to make the same mistake I have made by passing judgement on me because of my improper conduct. I appear before you as an imperfect man but also a man with a renewed desire to be the husband, the father, the Christian, the friend, and Commissioner I should have been all along. Thank you.

MINUTES OF THE GEORGE CORE PARK WORKSHOP FOR THE BOARD OF CITY COMMISSIONERS FOR THE CITY OF PORT ST. JOE FLORIDA HELD AT 200 MISS ZOLA'S DRIVE, December 12, 2017, 12 O'clock Noon

The following were present: Commissioners Ashbrook, Buzzett, and Lowry. City Manager Jim Anderson, City Clerk Charlotte Pierce, and Attorney Clinton McCahill were also present. Mayor Patterson and Commissioner Thursbay were absent.

Others present were PSJRA Director Bill Kennedy; Linda G. Wood, Operations Director Cape San Blas Lighthouse; Jessica Swindall and Charles Gaddy of the Florida Coastal Conservancy d/b/a The Forgotten Coast Sea Turtle Center, and Tim Croft.

The purpose of the Workshop was to provide a discussion on the rental fees for George Core Park.

City Manager Jim Anderson welcomed those attending and reminded the Commissioners of the Special Meeting tomorrow at Noon at the Ward Ridge Building.

Commissioner Ashbrook shared his thoughts on rental fees for the use of the park. He suggested that areas be designated, numbered, and charged accordingly.

Commissioner Buzzett reminded those present that there was an existing fee schedule and suggested that it be tweaked to accommodate the needs.

Discussion on the use of the Cape San Blas Lighthouse Keepers' Quarters, Eglin, was discussed. Consensus was that a Scope of Work would be provided by a structural engineer, floors would need to be redone, and the Florida Coastal Conservancy d/b/a The Forgotten Coast Sea Turtle Center could use the building until the lighthouse lens is ready to be displayed. The St. Joseph Historical Society, Inc., maintains the use of the building and all expenses of the Eglin Quarters will be the responsibility of the Florida Coastal Conservancy d/b/a The Forgotten Coast Sea Turtle Center. At the time the lens are ready to be assembled, ample notice will be given to the Turtle the Florida Coastal Conservancy d/b/a The Forgotten Coast Sea Turtle Center and they will vacated the building. City Attorney Clinton McCahill will draw up a contract between the St. Joseph Historical Society, Inc., and the Florida Coastal Conservancy d/b/a The Forgotten Coast Sea Turtle Center to be presented to the City Commission for approval.

The Workshop was adjourned at 1:00 P.M.

MINUTES OF THE SPECIAL MEETING OF THE BOARD OF CITY COMMISSIONERS FOR THE CITY OF PORT ST. JOE, FLORIDA, HELD AT 2775 GARRISON AVENUE, December 13, 2017, at Noon.

The following were present: Mayor Patterson, Commissioners Ashbrook, Buzzett, Lowry, and Thursbay. City Manager Jim Anderson, City Clerk Charlotte Pierce, Attorney Clinton McCahill, and Chief of Police Matt Herring were also present.

The purpose of the Special Meeting was to address the following:

Attorney General Opinion City Charter Sec. 2-27 City Charter Sec. 20

Attorney McCahill shared that a response had been received from Ellen B. Gwynn, Senior Assistant Attorney General Opinions Division stating "Opinions generally are not issued on questions requiring an interpretation only of local codes, ordinances or charters rather than the provision of state law. Instead such requests will usually be referred to the attorney for the local government in questions." The email from Ms. Gwynn also states that Section 775.08(2), Florida Statutes, expressly defines "misdemeanor" as a "criminal offense."

Mr. McCahill noted that, in his opinion, Commissioner Thursbay forfeited his seat by his plea to DUI with property damage.

Commissioner Lowry asked that Commissioner Thursbay remove himself from office based on the Charter.

Commissioner Thursbay shared that he had received numerous cards and letters of encouragement telling him what a good job he has done as a Commissioner and there was only 1 bad card in the bunch. He stated he would not step down and plans to run again. He also noted he has apologized, and this was the biggest mistake he has made.

Commissioner Buzzett noted that Commissioner Thursbay had been a good Commissioner, we all make mistakes, but this mistake was a violation of the Charter and that his seat has been forfeited as of last Wednesday.

Commissioner Ashbrook stated that he agrees that Commissioner Thursbay has done a fantastic job but as a Commissioner he has to uphold the values of the Charter and the attorney's opinion.

Mayor Patterson shared that he has issues with the Charter as it is ambiguous and not easy to interpret. He does not condone the actions of Commissioner Thursbay but everyone makes mistakes.

When asked his interpretation again, Attorney McCahill responded that pleading to a DUI with property damage forfeited his position by law.

Commissioner Lowry reiterated that pleading forfeited the position.

Commissioner Buzzett asked for the attorney's interpretation again and Mr. McCahill responded that pleading to the DUI with property damage forfeits his position by law.

A Motion was made by Commissioner Buzzett, second by Commissioner Ashbrook, to approve the opinion of the attorney.

Commissioner Lowry stated that he did not feel that a Motion or a second was needed, and that he did not come here to vote to remove Commissioner Thursbay. He again asked Commissioner Thursbay to forfeit his seat.

Attorney McCall again stated that Commissioner Thursbay forfeited his office with his plea.

Commissioner Buzzett withdrew his Motion and Commissioner Ashbrook withdrew his second.

Commissioner Thursbay stated he would seek legal advice and will be out knocking on doors in 5 months. He left the meeting at 12:12 P.M.

Consensus of the Commission is that Saturday is the last day to appoint someone to fill the seat previously held by Commissioner Thursbay or someone will be appointed by the governor. There will be a Special Meeting on Friday, December 15, 2017, Noon at the Ward Ridge Building for the purpose of filling the vacancy of Commissioner Group I. Individuals interested in serving until the next election in May should provide their names to City Hall for consideration.

Citizens to he Heard

Christy McElroy addressed the Commission stating this was a sad issue, she had support Commissioner Thursbay and contributed to his welfare, but this was a major issue which carried consequences and responsibilities for this actions. Ms. McElroy expressed her thanks to Chief Herring and his department for doing their job throughout this issue.

David Alvarez stated that he felt the leaving of Commissioner Thursbay from the meeting forfeited his seat.

Steve Womack asked that if Commissioner Thursbay should show up on Friday what the plans would be. He also noted that he was a 28 year Army Veteran, felt that Mayor Patterson had failed in leadership, and noted that he should possibly reflect on his values and conduct and suggested that Mayor Patterson might want to resign also.

Mayor Patterson responded that he could bring lots of people that like his leadership.

Teresa Thursbay stated that she does not condone the actions of her husband, he has been a good commissioner and learned who the people are that he can count on and who the back stabbers are. She noted that she does not care about the decision of the Commission, her husband is a good man, there are those present who drink and drive that have just not been caught and stated, "Shame on you." She noted a sitting Commissioner had a DUI prior to the time of their election.

Rob Lacascid thanked the Commission for following the Charter.

Barbara Radcliff stated that no one hates William Thursbay but there are consequences to his actions. DUI is a crime, and no one is punishing him.

Keith Croasmun asked that the Commission not change the law, and to hold to themselves to higher standards.

Christy McElroy again addressed the Commission and asked that an Incident Event Report be entered into the Record showing a text she received from Teresa Thursbay. See Exhibit (A).

Mayor Patterson concluded with noting the City Charter is not like the County's or State. There are currently two legislators serving who have DUIs and noted they have not been removed from office but have been taken off several committees.

Discussion Items by Commissioners

Neither Commissioners Ashbrook, Buzzett, Lowry, nor Mayor Patterson had anything else to discuss.

A domestic wastewater inspection was conducted at your City of Port St. Joe Wastewater Treatment Facility on May 31, 2017, under the authority of Section 403.091, Florida Statutes (F.S.). During this inspection, possible violations of Chapter 403, F.S., Chapter 62-600, Florida Administrative Code (F.A.C.), 62-610, F.A.C., and Chapter 62-640, F.A.C., were observed.

During the inspection and subsequent Department personnel noted the following:

- From January 2016 through July 2017 the facility reported effluent total suspended solids monitoring results above its permitted limit (reference inspection report, section 9.)
- Cat tails were present in the spray field, indicated standing water, which is not allowed by the permit (reference inspection report, section 10.)
- The sprayfields had patches that were overgrown with vegetation, and needed maintenance (reference inspection report, section 10.)
- A few additional items rated as "minor-noncompliance" are documented in section 5. of the attached inspection report and require the City's attention.

Violations of Florida Statutes or administrative rules may result in liability for damages and restoration, and the judicial imposition of civil penalties, pursuant to Sections 403.121 and 403.161(2), Florida Statutes.

Please contact Kim Allen, at (850) 595-0553, within 15 days of receipt of this Warning Letter to arrange a meeting to discuss this matter. The Department is interested in receiving any facts you may have that will assist in determining whether any violations have occurred. You may bring anyone with you to the meeting that you feel could help resolve this matter.

Observation: The facility has a 1.9 million gallon per day (MGD) annual average daily flow (AADF) permitted capacity discharging to a 97.85-acre slow-rate restricted public access spray field (R-001). The facility's sprayfield and were evaluated during this inspection.

Observation: Permit Condition IV.A.1: Advisory signs were posted around the site boundaries designating the nature of the project area.

Observation: The monitoring wells were capped, labeled and locked.

Observation: Permit Condition IV.A.4.: The loading to the spray field is not exceeding the permitted limit of 5 inches per week.




Figure 1 Large patches of cat tails were present on certain spots of the spray field.

Deficiency Description: The presence of cat tails in the spray field indicated standing water (Figure 1).

Permit/Rule or Other Reference: Permit Condition IV.A.4.: The hydraulic loading rate shall not produce surface runoff or ponding of the applied reclaimed water. [62-610.423(3) and (4)]

Corrective Action: In your response to this report, please address how you will handle the ponding on the spray fields. LOW AREA NEEDS FILL DIFT / SAND.

<u>Deficiency Description:</u> There were patches of vegetation that were very overgrown on the spray fields (Figure 1).

Section 5.

Reference Rule 62-602.650 Hard bound operator log book.

At the time of inspection we did not use a hard bound book for operator logging. Hardbound books were ordered from Ramsey's printing and we are and will utilize these hard bound books for operator logs. (In service 6-16-17)

Reference Rule 62-555.360 Hydrant backflow device annual testing.

At the time of inspection we did not have a copy of a valid back flow test. "Plumb Better" was called and successfully tested the backflow preventer on 10-2-17. The test will be scheduled annually in October. (No one in Gulf County has the license to test backflow preventers anymore.)

Section 9.

At the time of inspection we had violations of our effluent permit conditions in pH, TSS, fecal coliform % less than detection, and total residual chlorine.

To improve control over the effluent pH, we have added a flexible piping system which allows the operator to choose where in the water column our effluent is taken. We have since found the optimum placement for pH control. July 21, 2017 we locked the intake pipes at the desired level with the ability to change if needed. Since that day we have had 2 pH violations (neither can we explain) and the pH is now averaging in the low to mid 7's.

To improve our control over disinfection, we have repaired then replaced the holding tank and feed line for our sodium hypochlorite (disinfection) tank which allows us to utilize the lower 600 gallons thus resolving our disinfection pumps from sucking in air when we had hundreds of gallons in the holding tank.

Our TSS issue is our biggest issue and we have a short term and long term plan. On the short term we plan to discharge just short of our permitted limits throughout the winter months while the algae is low. This should allow us a couple of months in the summer to hold any discharge if the lagoon is algae laden, thus lowering our annual average. Our solution will be to add microorganisms (biological dredging) to the lagoon that breaks down the nutrients, thus removing organics/ sludge and starving out the algae. (Results of one trial is at: http://www.sea-today.com/index.html) We have had two trials from different companies, both removed sludge from the trial area, and one impacting the algae significantly in the trial area. Another avenue may be to fence off the spray fields. We do not have the answer as to how much that will affect the permit limits, so until we have those potential permit values, we do not know how much impact this well have.

Section 10.

At the time of inspection a portion of Zone 5 at our spray field had some overgrown vegetation indicated by the presence of cat tails.

Prior to the inspection, we had noticed a low area in that particular zone and decided to valve off the sprinkler heads in that area, and choose to bypass the zone all together as much as possible. That area is now dry again and maintained with the rest of our spray field. At the time of the inspection we were scheduling equipment training with a "borrowed" operator (Tommy Gay). We have since filled our ranks with two operator trainees and now have the ability to borrow a trained tractor operator to fill in as needed.

2014: Sodium Hypochlorite pre-injection trials

2015: \$34,530 for Sonic Disruptors

2016: Trials of microbial dosing

2017: Trials of microbial dosing

Case Study #5

Port St. Joe, Florida, Oxidation Pond

Overview

Sea-Today, LLC started growing and then adding its' multi-specie culture (ST-13) to the Port St Joe Oxidation (PSJ) Pond (Fig 1). The pond supports about 3,500 residences and buildings. The pond is 78 acres and is an old mill pond that was given to the City in 1997. It was supposed to have been dredged in 1997, but it has 5 feet of mill sludge and on top of that is 2 to 8 feet of sewage sludge. The total depth is typically 13 feet. The pond is almost full of sludge in some areas and is going to need to be dredged in the next 5 years. The current estimate is \$12 million to \$15 million to perform the dredging and haul the sludge to a land fill. The City is looking for a way to push out and minimize the cost of dredging. We focused on about a 5 acre area at the southwest corner of the pond. Over a four week period we reduced the sludge by 8 inches(Fig 3). The plant had been outside permit levels in TSS and pH for a long time. Within a week of our start the TSS and pH were both within permit levels(Fig 5). They also had an ongoing problem with odiferous algae that went away shortly after starting and remained gone until we completed the study. Based on our results we forecasted that the City could push out the dredging by at least 20 years, saving millions of dollars.

Treatment Plan

The entire study lasted 6 months. We started in the influent area and then moved around the pond to eliminate their odiferous algae problem. We then focused in on about a 5 acre area of the pond to document sludge reduction over a four week period, using a manual sludge judge to measure sludge levels before and after. Each week, 500 gallons of culture was grown four different times over a 24 hour period and then drained into specific sites at the edge of the pond.

Results

We analyzed their two layers of sludge and found they had equal bioactivity which measured the biology's ability to consume the organics. The <u>sample</u> was 59% inorganic and 41% organic. The algae problem was eliminated shortly after starting and remained absent during the 6 month test. The site saw a reduction in TSS and a reduction in pH within a week of our starting and both levels went from outside permitted levels to within permitted levels and remained there until the end of the test period.

The 5 acre test area showed a reduction of 8 inches over a 4 week period. This would push out their need for dredging by about 20 years, allow the City time to accumulate funds to perform the work, and save them millions of dollars.

The pond's water quality changed over the study time. The water clarity started to improve and the overall <u>health</u> of the pond improved. As a result, the small fish population increased greatly, and then the bird population increased. The odor was also eliminated.

The test demonstrated everything Sea-Today, LLC had claimed.





Fig 2 Test Locations for Sludge Judge


