## **Proposed Tasks:**

- Task 1: Provide education and training to City Commissioners and Staff on Florida Statue, Chapter 163, Part III.
- Task 2" Conduct a review of past CRA activities and projects, and provide recommendations.
- Task 3: Provide template/procedures and guidance for filing CRA Annual Report and review of other CRA compliance Items (does not include developing or filing of reports).
- Task 4: Provide recommendations for the CRA to create a Community Advisory Committee Board.
- Task 5: Educate the CRA and City Staff on how CRA funding can be used to leverage local public funds and private funds to incentivize private investment in NPSJ.
- Task 6: Provide examples of recommended policies and procedures for consideration by the CRA and City Staff.

#### Compensation (Lump Sum)

The proposed tasks listed above will be completed on a lump-sum basis for \$9,750. Please note that this fee does not include any fees for public meeting space or meeting notifications to local stakeholders or filing of any CRA Annual Reports
