SURFACE WATER PLANT OPERATOR

NATURE OF WORK

This is shift work in the operation and maintenance of the water treatment plant and auxiliary equipment. An employee of this class is responsible for operating and coordinating the activities of the of the water plant and booster stations. The Operator works under the general supervision of the Water Plant Supervisor.

- Performs routine sample analysis for process control.
- Participates in periodic rounds of the treatment plants and auxiliary power equipment.

SURFACE WATER OPERATOR TRAINEE

NATURE OF WORK

This is shift work in the operation and maintenance of the water treatment plant and auxiliary equipment. An employee of this class is responsible for operating and coordinating the activities of the of the water plant and booster stations. Trainee works under the general supervision of the Water Plant Supervisor, as well as the licensed operator on duty. Trainee's work is reviewed while in progress and upon completion, through observation, reports and logs submitted.

EXAMPLES OF WORK (May not include all of the duties performed)

- Performs routine preventative maintenance.
- Performs adjustments to operational equipment with the licensed operator's knowledge.
- Performs routine sample analysis for process control.
- Participates in periodic rounds of the treatment plants and auxiliary power equipment.

- Participates in making operational adjustments to various treatment processes (ie chemical feed rates, pump speeds).
